**From the WSFC President,
Dwight Pace**

First, our thanks to Tri-Cities Chapter 1192, and especially their excellent planning committee for the very successful 2006 WSFC Convention. Johanna Caylor and Carl Gallion, Co-Chairs, and the WSFC Board, did an exceptional job of putting together a fun, informative, and interesting meeting. Evaluations for each day were generally very complimentary. Any glitches are certainly details that can be worked out next year. I want to discuss a few of them with you.

First, it is a challenge to know how much time to plan for the various issues. I was surprised that there was not more discussion about Resolutions and Bylaws. We have had conventions in which these two items used so much time that other items on the agenda were neglected. A need for training on writing these, and the importance of meeting deadlines, needs to be a topic of training with your district Vice President.

I am extremely pleased with the work of the Newsletter Committee and their judging of the newsletters. However, we failed to explain one important aspect of the judging, namely, the color categories. Every chapter's newsletters were judged according to a score sheet, with each judge working individually. Scores were then tabulated with ribbons awarded accordingly. Chapters with superior scores were awarded blue ribbons, good scores, red, and average scores, yellow. It is my sense that more chapters are doing newsletters and that the quality of chapter newsletters is improving, and I am very pleased.

Finally, your Federation Executive Committee will study the evaluations and incorporate your suggestions in next year's convention. Bremerton Chapter 181 and Convention Chair, Amber VanSantford, are already working toward a super 2007 convention at the Silverdale Beach Hotel (formerly Red Lion) May 16-18. This is also Armed Forces Week, and Bremerton will be having a big, big community event, parades and all. Amber is capitalizing on our convention and Armed Forces recognition. A reminder to all: make your reservations NOW if you even *think* you will attend.

On July 27, 2006 the full WSFC Board will meet at the LaQuinta Inn in Tacoma, starting at 9:00 AM. We have a full agenda as we plan for events of the

coming year. If you have items for the Board to consider, be sure your District Vice President is briefed and carries your message. Members are welcome to attend as observers.

Among items the Board will discuss are the proposed bylaws changes to be voted upon at the Albuquerque convention, namely, (1) one person, one vote by mail vs. representative voting, (2) mandatory chapter membership vs. open membership, and (3) streamlining the dues structure. The Board does not vote on these issues since they are matters for chapters to determine. We remind you, however: if you have opinions about these and other issues, be sure that your chapter is represented, either by chapter delegates or proxy and that they are informed of your chapter's position on the issues.

As we move into the off-year election season, I urge all to stay involved with our NARFE political agenda. We have serious threats to our health care. For one, the administration is proposing that Blue Cross be allowed to offer Health Savings Accounts. NARFE opposes this.

Remember, an old political ruse is to raise one or two value-laden issues and focus much attention on them. This keeps voters stirred up and off balance by creating problems or issues around a single item that is value laden and has been discussed for generations on end at the cost of ignoring other pressing matters. We must focus on our issues –the issues of protecting our earned retirement and health benefits.

Summer – July, August and September – is a great time both for being visible and getting ready.

Being visible. Every community has its public events in the summer – parades, festivals and gathering of all kinds. If there was ever a time to run into both current and retired Federal employees and annuitants, this is it. Is your chapter planning to be out there – by walking in the parades, manning a booth, handing out NARFE material, or helping in many of the volunteer support roles? Will they have something that clearly identifies them as NARFE – a hat, a jacket, a t-shirt? Will informational and recruiting materials be ready and available for distribution? Will your members be primed and ready to talk about NARFE objectives and actions? Are you thinking about how to get local media coverage of your events? Don’t let the chances pass you by. If there are fees for participation, contact me to discuss the possibilities for support.

Getting Ready. Now is the time to be planning and ordering literature for fall promotional activities such as health fairs and pre-retirement seminars. The basic scheduling information is already out there and more will be provided soon, so you have a general idea of the numbers you need. Planning information is also available on the Federation web site.

Evergreen Chapter 1801 – Gary Robertson

At a recent chapter meeting, we had two special guest speakers: Rep. Adam Smith (9th District) and NFVP Lanny Ross. At the March meeting, Pete Malsch gave a presentation on the AARP Driver Training Program (we found out about it from another chapter in District II).

One of our chapter members, Betty Strah, is involved in this program. These programs cost about \$10 to attend, but you easily recover the money, as most insurance companies will give you an additional discount on your auto insurance premium.

In Federal Way, the course is given at a library, senior center and retirement housing complex. Pete also gave us another very important tip to improve your driving: by using your rearview mirror to track cars behind you and extending your side view mirrors slightly out (so you cannot see the cars behind you), you can eliminate your "blind spot" which can help prevent an accident when changing lanes.

"To keep the discount on your auto insurance premium in effect, you have to take the course every two or three years (check with your insurance company for their requirements)."

At the February and March chapter meetings, Co-President/Membership Chair Gary Robertson presented certificates and gold membership cards to six new Honorary Members: Leona McConville; Minda Petersen; Evelyn Rensch; Fern Buzard; Dominic and Florence Pirozzi. The chapter also voted to waive chapter dues for these members.

2006 FEHB OPEN SEASON HEALTH FAIRS - Natalie Leath, FEHB Health Fair Coordinator

Each Chapter President will receive a copy of the final health fair calendar of events, a list of FEHB health plan representatives and the list of agency contacts by the end of August.

For chapters not hosting a FEHB health fair, it is recommended that Chapter members attend the nearest agency or NARFE Chapter health fair, listed on the calendar. Please review the calendar to determine the location of a health fair in close proximity to you. Health Fair event locations, time and date, can also be listed in your Chapter newsletter.

If your Chapter would like to represent NARFE at an agency health fair, you MUST contact the agency coordinator for authorization.

The Open Season is a very busy time for the NARFE supply room. If your chapter is hosting a chapter health fair or REPRESENTING NARFE at an agency Health Fair you should order your NARFE materials NOW. It takes 4 – 6 weeks to receive materials from NARFE Headquarters.

It is strongly recommended that Health Plan Representative presentations be scheduled BEFORE you begin your chapter business meeting. That will free up the carriers to travel to their next scheduled health fair.

MEMBERSHIP – Lois Pace

In the last *Federal Reporter* we talked about “**Values and Membership**,” raised the issue of value differences between generations, and posited the idea that we need to be aware of these differences if we are to engage coming generations in NARFE. Before we get to the Gen Xers and Gen Yers, here’s a quick review of the Traditionalists and Boomers.

Most who take an active role in NARFE—attend chapter meetings, serve as officers, attend Federation and National Conventions as delegates—were born before 1945 and carry the name, **Traditionalists**. They grew up with stay-at-home moms, experienced the Depression followed by World War II, rationing, the era of big bands, managed money by saving it, and were glad to have a job. They value privacy, hard work, trust, formality, authority, and things.

Boomers, born between 1946 and 1964, were influenced in their formative years by events of the Cold War, Civil Rights, the Space Race, the Vietnam War, Kennedy’s assassination, and Watergate. Overall, getting a job has posed little problem for them. Generally, this group has not experienced economic hard times. They are good at relationships, want to please, and will fight for a cause.

Now for the younger generations - **Gen Xers** are those born between 1965 and 1981. Events and developments occurring in their growing-up years included Chernobyl, Lockerbie, Starbucks, violence in the schools and on the streets, AIDS, drugs, and concerns for personal safety. Raised on sound bytes, they are resourceful, independent, and count on themselves to get things done. Core values for the Gen Xers include diversity, thinking globally, having fun, informality, self-reliance and pragmatism. They are adaptable, creative, and are not intimidated by authority.

Supportive Behaviors for Communicating with Generation X:

- ◆ Use email as a primary communication tool.
- ◆ Use feedback—ask for their feedback, provide them with regular feedback.
- ◆ Use an informal communication style.
- ◆ Talk in short “sound bites.” (Consider how music in worship has shifted from hymns to choruses!).

The Gen Y group, aka Echo Boomers, Millenials, or Nexters, were born between 1982 and 2003. Older ones of this group experienced the Oklahoma City bombings, Columbine, and 9-11. They are very comfortable with the Internet, IPODs, and electronic gadgetry and use them extensively. As they enter

employment, they are said to be conscientious, skilled at networking, appreciate diversity, and casual dress. Core values of the Gen Y are optimism, civic duty, confidence, achievement, sociability, street smarts, and diversity. Their greatest assets are their tenacity, multi-tasking capabilities, and technological savvy.

Supportive Behaviors:

- ◆ Challenge them with action words.
- ◆ Don’t talk down to them.
- ◆ Use email.
- ◆ Don’t take yourself too seriously.

Volunteer organizations everywhere are facing membership problems. Like all others, NARFE struggles to find the “magic key” to build our enrollment. Traditionalists must be willing to adapt to the needs of Boomers, Gen X and Gen Y if we are to survive. As you ponder the core values, assets, and supportive behaviors of the different generations, consider how you might build on them to recruit and retain them in your chapter. The future of NARFE depends on it!

This is my first hello to members as Federation Vice President. Having been newly elected to this position at the recent WSFC Convention I have very little to report. First and foremost, my heart felt appreciation to those chapters and individuals who supported me for the job.

National Convention in Albuquerque.

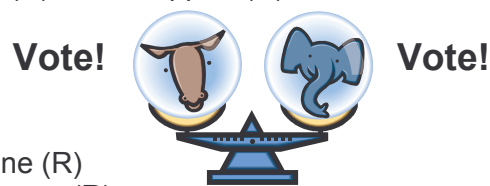

NARFE Legislation

Bill Name: Premium Conversion to allow Federal Civilian and Military retirees to pay health insurance premiums on a pretax basis. Bill Number: H. R. 994. There are currently 333 House cosponsors of this legislation. The Senate has 62 cosponsors for bill S. 484.

Cosponsors: Jay Inslee (D-1st); Rick Larsen (D-2nd); Richard (Doc) Hastings (R-4th); Norm Dicks (D-6th); Jim McDermott (D-7th); Adam Smith (D-9th); Not a cosponsor: Brian Baird (D-3rd); Cathy McMorris (R-5th); and Dave Reichert (R-8th).

On June 13th, NARFE, NTEU and AFGE testified before the Government Reform Committee's Subcommittee on the Federal Workforce Bill H.R. 4859 on Health Information Technology in FEHBP. Their testimony led to the promise of significant changes to the legislation. (This was removing access to the administrative fee and inserting language to provide an alternative method, such as a Call Center, for enrollees to create, access and edit their own Electronic Health Records). President Fallis, in his oral testimony, stressed absolute protection of enrollees' medical records. See the May issue of NARFE magazine, pages 14-16 and full coverage, with photographs, in the August issue of *NARFE*.

NARFE President Charles Fallis praised Senators Wayne Allard (R-CO) and Ken Salazar (D-CO) for introducing legislation S.2801 to allow disabled dependents of federal workers to receive a survivor annuity through a trust without affecting eligibility for Medicaid – just like their counterparts in the private sector.

For purposes of calculating the next COLA, May's index is 2.9 percent higher than the third quarter average base index in 2005 (192.7). The Federal Employees Compensation Act (FECA) May index, 198.2, is 3.0 percent higher than the December 2005 index (192.5).

Questions at the State Convention in Richland posed a couple of issues concerning the granting process about NARFE-PAC that were only partially answered. So, with help from National, here is a short course on what happens to your donation.

Donations are collected from members and their families. These are voluntary, not tax deductible and not from any commercial transaction such as a bake sale. These monies are not mingled with chapter funds but sent directly to National NARFE-PAC by the chapter NARFE-PAC chairs with a list showing the donors' names, addresses and amounts given. The chapter chairs issue pins and National will mail receipts of the donations to the individual donors.

The scenario goes something like this: The political candidate requests a donation from National. They, in turn, contact the State NARFE-PAC Chair (me, for now) for advice. In Washington, I ask the President and/or chapter NARFE-PAC chair for input as to whether or not to recommend the grant. This is sent by e-mail as time is short – usually two weeks.

The chapters should consider the candidate's voting record, stand on Federal employee and annuitant issues, the status of their war chest, etc. Usually you have 2 weeks to get back to me and I'll pass it along to National. If there is no response, I will do my best to check out the candidate and notify National.

The decision as to grant or not resides with the resident officers with support from the legislative assistants and Budget and Finance. Our input has high value but other things must be considered such as their voting record (for incumbents), their legislative influence to support NARFE's issues, the degree of communication with members, chapters and federations of NARFE, their chance to win, etc. Funds can be and are expended in primaries.

National notifies the candidates and expends the funds directly to their campaign people. A legislative assistant contacts me about the grant and if there is a kick-off or other function. I will notify the chapter(s) of the grants and it will be posted on Federation web site. Quite often you will know about these functions before I do. I will request one or more of you to attend the function in behalf of NARFE-PAC, if there is time.

If there is a special situation where you want me to

push the candidate's request for funds with National, please contact me.

CHAPTER NEWSLETTERS – David Seesholtz, Editor

NEWSLETTER CONTEST:

Fourteen chapter newsletters were judged at the WSFC Convention in May. Felix Entenmann, Art Reis, Lois Pace and myself did the judging using the criteria shown on the next page. We all need to thank them for the extra time they spent behind the scenes at the convention to get this job completed. They probably would have gotten to socialize more if the judging had been done prior to arriving. Hopefully, next year we will do the judging before the convention. I personally want to thank each judge for a great job.

Every chapter (14 total) that submitted their complete volume of issues for the entire year prior to the convention received a certificate and ribbon. The judges all agreed that every chapter that has a newsletter is a winner and should receive recognition.

We determined the blue ribbon awards by adding up the total points on the judging forms and giving blue ribbons to those who scored 90% of the total points possible. It was possible to earn 75 points and since 90% of 75 = 67.5, those chapters receiving more than that many points were given a blue ribbon. There were 7 blue ribbons awarded.

We gave out 5 red ribbons to those chapters that received more than 80% of the possible points (60 points). The other two chapters were awarded yellow ribbons.

SUMMARY OF COMMENTS:

Some of the comments made by the judges are listed below:

- ◆ You need to include the correct name of the organization
- ◆ Chapter should strive to increase the publication frequency to monthly
- ◆ Include contact information for officers
- ◆ Need contact information for US Senators and Representatives
- ◆ Need more complete information about the chapter meeting
- ◆ Too many font styles used
- ◆ Copied items look like patches
- ◆ Need more input from the elected officers
- ◆ Use the new logo
- ◆ Overuse of text boxes (everything was in a box)
- ◆ Paragraphs were too long

- ◆ Try using two columns once in a while
- ◆ Need more about legislative information
- ◆ Label is located where it damages the text when the newsletter is opened
- ◆ Use more highlighting and or bullets to help the reader find important information

The overall impression of the judges was that the newsletters were better than we had expected. This indicates a continuing commitment by you toward improving your newsletters. We hope that the judging criteria on the next page and the information presented at the newsletter workshop will also help you produce effective newsletters.

Since the WSFC Executive Board doesn't meet until July 27th, I can't say for sure that we will be judging newsletters at the 2007 Convention. President Dwight has made "improving newsletters" a high priority so there is a good chance that we will be giving awards of some kind.

Each chapter that has a newsletter should send me a copy each time it's published. Once we decide to do judging and select about three judges you will also be asked to send them a copy.

NEWSLETTER WORKSHOP:

Approximately 60 people attended the newsletter workshop at the convention. Those present received a printed handout that could help you write, design and layout a successful newsletter. If you are an editor or chapter president and did not receive one of these let me know and I will send you one.



One of the things that I discovered during this workshop is that the newsletter needs to receive more attention from the chapter leadership team.

One suggestion is to make the newsletter an agenda item. At this chapter leadership meeting use the judging criteria to determine how you are doing. Ask the question, "what do I want the readers to do", (come to the meetings, retain their membership and/or contact their elected officials)? Then be honest and talk about whether it is doing what you want.

Also, remember that the newsletter is the only contact that you have with 90% of your members. It's very important that you make them feel that their chapter membership is a good value.

FEDERAL REPORTER – Dave Seesholtz, Editor

For the past couple of years, Natalie Leath, who has been the editor of this newsletter, has been trying to convince me that I should volunteer to be the next editor. Natalie has been wearing many hats for the federation, such as Health Fair coordinator, National Legislative Chair and editor. A couple of months ago I finally agreed to become editor if President Dwight was ok with it. So now I'm your new editor.

Natalie has done an excellent job as your editor. During some of the years she served in the position I received copies of the federation newsletters from all around the country. Natalie has shaped our "Federal Reporter" into one of the best in the nation. She will be a hard act to follow.

In the short time that I've been editor, one of the district vice presidents has suggested that the "Federal Reporter" should be sent to all the members in the state at least once a year. This topic will be discussed at the executive board meeting on July 27th. My first reaction to this suggestion is that it is not the purpose of this newsletter. Some of my thoughts are listed below to help everyone understand the situation:

- ◆ The "Federal Reporter" is presently sent to the chapter and federation leaders, a small mailing list of about 240 people.
- ◆ There are about 10,000 NARFE members in the state.
- ◆ The budget for the "Federal Reporter", in the Federation Budget for 2006-2007 displayed

- ◆ elsewhere in this issue, is \$2700. This covers 4 issues, which are sent quarterly. It also covers the editor's expenses to attend district meetings.
- ◆ The printing cost is about \$2.00 per copy and it costs about \$.50 to mail a copy.
- ◆ The cost of printing and mailing 10,000 copies would be more than we could afford. It could be in the range of \$20,000. The federation would have to increase the per capita tax substantially to have the finances to make just one mailing to all the members.
- ◆ The executive committee needs to look at the purpose and mission of the federation. Some of this is in the National and Federation Bylaws. My interpretation is that we presently have our newsletter aimed at the chapter and federation leaders, which is the right readership.
- ◆ Mostly, it is the executive board members that write the "Federal Reporter", with occasional input from chapters. It is important that each person writing for this newsletter understands that our mission is to help the chapter leadership do their jobs efficiently and effectively, not to do their job for them.
- ◆ It is very important that we continue to encourage every chapter to have a successful newsletter. This includes helping chapters who do not have one get one started.

Please be patient with me as I assume the duties of editor. If you have suggestions, or want to write an article, please feel free to contact me.
